To acquire, hold, and manage land and interests in land, and to engage in activities, all for the protection, preservation, and restoration of the scenic and natural resources of the Chocorua Lake Basin and surrounding area. Conduct and model sustainable forestry. Protect Chocorua Lake water quality. Permit and manage public access for passive recreation where appropriate. Conduct education and outreach to sustain volunteer community support of the mission of CLC.

Land Conservation - Began work on two new conservation easements, one to help protect over 100 acres of uplands associated with the upper Chocorua River, and the other to prevent commercial development around a historic dam on the River in the center of Chocorua village. The CLC is responsible for 76 conservation covenants and easements covering 2960 acres and continues to develop landowner relationships and annual monitoring practices. A focus this year has been on communications with the second generation landowners. The organization successfully resolved a violation on one property pertaining to density requirements and boundary setbacks.

4b (Code:) (Expenses \$ 43,866 including grants of \$) (Revenue \$)
Education & Outreach - Sponsored a number of workshops, walks and educational talks. A number of events were planned to draw together community members in partnership with the Arts Council Tamworth. In collaboration with Tin Mountain Conservation, we worked with the local elementary school teachers to create outdoor programming on Lake Chocorua, using science and art to provide opportunities for third and sixth graders to work together. Community events later allowed students to share their work and experiences. We continued to provide events for CLC members and the general community, and produced two newsletters sharing information about our work and stewardship of the Lake Chocorua area.

4c (Code:) (Expenses \$ 38,952 including grants of \$) (Revenue \$)
Lake & Property Management - Together with staff and volunteers, continued to oversee and manage nearly 1000 acres of fee owned lands around the Chocorua basin. This includes maintaining hiking trails on four properties; maintaining public access on Lake Chocorua for swimming, non-motorized boating (per state law), picnic-ing and fishing; and practicing sustainable forestry and wildlife habitat improvement. With the help of a grant from NRCS, addressed invasive plant control around Lake Chocorua, working with professionals to target Japanese knotweed, bittersweet and glossy buckthorn. This was the 38th year of water quality testing on Lake Chocorua in cooperation with the Lakes Lay Monitoring Program through the University of New Hampshire.

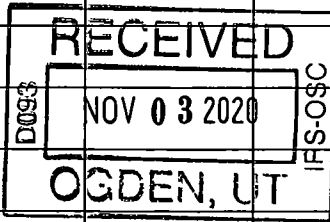

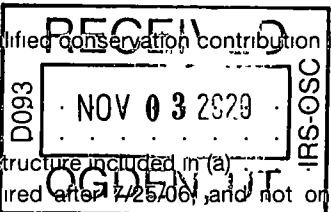

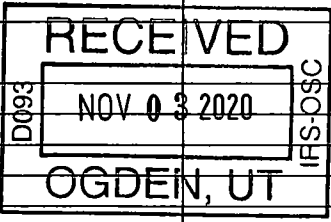
