LAND CONSERVATION In 2019, SELT conserved a total of 3,263 acres of land, bringing the organization's cumulative impact to nearly 23,000 acres. SELT's conservation work continued to focus on three key areas: Living Landscapes, Clean Drinking Water, and Farmland for the Future. Projects include SELT's acquisition of fee lands and easements and assisting federal partners in acquiring conservation easements.

Under our Living Landscapes initiative, SELT seeks to conserve large landscapes critical due to their abundant natural resources, water quality, ecological integrity, wildlife habitat, and recreational opportunities. Embedded within our Living Landscapes initiative is an effort to connect through conservation land Pawtuckaway State Park to the Great Bay known as the Pawtuckaway to Great Bay Greenway. 11 such projects were completed, with the highlight being the 2,027-acre Birch Ridge Community Forest in New Durham, SELT's largest ownership. EASEMENT STEWARDSHIP In 2019, SELT completed its 12th consecutive year of annually monitoring all 197 conservation easements to ensure continued protection of the natural resources of these conserved lands. We also worked with our partners to support their monitoring of the 44 easements which we hold the executory interest on (back up to the primary easement holder). Finally, we contracted with municipalities to monitor 24 town conserved lands. SELT completes this work through two full time and two seasonal staff members complemented by our ongoing Volunteer Easement Monitor Program. In 2019, monitoring was completed primarily through property visits. SELT continues to seek ways to build cooperative relationships with our original and successor landowners. SELT produced two issues of our landowner newsletter, Everlasting, providing informative articles on best management practices and ownership of conserved land. SELT also sent "anniversary cards" to all easement landowners, to remind them of the conservation tradition and build a more personal relationship. CONTINUED-SCHEDULE O

LAND MANAGEMENT SELT's owned land increased to 36 reservations totaling more than 8,200 acres, with the largest addition being the Birch Ridge Community Forest. There, SELT focused on the development of a comprehensive management plan, working with the Community Forest Steering Committee, with the goal of adopting it in 2020. SELT's primary focus in 2019 was implementing the new trail system at the 1,700-acre Stonehouse Forest in Barrington, which totals 11 miles. A grand opening was held in the fall, attended by more than 100 enthusiasts. At our Franklin-McElheny Preserve in Dover and Rollinsford, SELT's community working group completed its work on how to best manage a hemlock wooly adelgid infestation, public access, and scenic beauty, recommending a phased approach that we hope to implement in 2020-21. In Newfields at the Piscassic Greenway, SELT completed a 300+ foot long boardwalk to create a year-round loop for wildlife viewing and hiking which has been received well by the public.
