Most land, monuments, landscaping, computers, other assets built or acquired for use of the cemetery is turned over to the State of New Hampshire on a regular basis throughout the year. The assets remain at the Veterans Cemetery and are overseen by the NH Veterans Cemetery Association, but ownership resides with the State of NH.
