Red Spruce Grove campers learn to live off-the-grid, unplugged and close to the land. While cooking over an open fire, they create tasty meals, build shelters, learn ax and knife safety, archery and other wilderness-living skills. This camp is for Girls and gender non binary. And for our youngest campers, the Barn Day Camp offers day programming which includes swim lessons, arts and crafts, nature and trip skills, building projects and many other great adventures!
