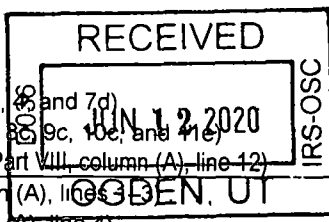

Form 990, Part III, Line 4a As in prior years, REC Ministries (REC) was requested by many  
struggling churches to assist them where possible to remain open and develop new guidelines to  
refinance debt, install new leadership, setting growth principles, etc. Churches in Florida,  
Mississippi, Alabama, and Georgia have been helped in some way by REC, Dr. Cottle, and other  
personnel available to the ministry

Form 990, Part III, Line 4a During the year 2019, Dr. Cottle's schedule was busy with his  
teaching ministry and other aspects of ministry. The move of the REC facilities to the lower  
portion of their home in Cataula has been a great move that allowed the ministry to operate  
more efficiently. During the year, Dr. Cottle taught often on Facebook and made various  
out-of-town ministry trips, including trips to Augusta, GA, Raleigh, NC, Macon, GA, Dallas,  
TX, Dunwoody, GA, and Ayden, NC. In addition, Dr. Cottle is constantly on the phone and in  
local meetings assisting a number of other ministries and churches as the need might arise.

Form 990, Part IV, Line 28 In the year 2018, it became apparent that the ministry could  
better serve others if the REC offices could be moved to the Cottle home in Cataula, GA. The  
basement of the home offered an ideal location for the offices and filming studios and the  
move was finally completed at year-end. Time has already shown that the move was a good one.  
Under the guidance of REC's CPA, it was determined that any rent charged the ministry would be  
simply to reimburse for costs incurred based on actual square footage used for ministry  
purposes.

Form 990, Part VI, Section B, Line 12a The ministry has adopted a "Conflict of Interest"  
policy that is consistent with the one recommended by the IRS and the ministry CPA.

Form 990, Part VIII, Line 6 In May of 2017, REC obtained the title to a struggling church in  
Warner Robins, GA. A new fellowship is now meeting in the church and hopefully will grow in  
numbers and faith. Presently, the church pays a monthly rent to REC and the rental income is  
shown on Line 6 of the Income Statement. Expenses shown against the rental income includes

depreciation and real estate taxes. Even though the property never ceased to be used for

ministry, the county assessed taxes during the transition period. Due to the threat of a tax

lien, REC did pay the assessment totaling approximately \$3,800. It is hoped that in the future

the church might have the financial ability to purchase the real estate from REC.

grandson, Roman, is the only other full-time salaried employee and his help and assistance

with the ministry has been invaluable. Roman's wife (Kyra) has donated many hours to the

ministry as well as taking care of much of the administrative duties required by the ministry.

Form 990, Part IX, Line 16 With the move of ministry offices, filming studios, etc. to the

Cataula home, the office and studio facilities leased and formalized by a lease agreement were

no longer needed. Accordingly, as of the end of 2018, three rental payments (October,

November, and December) were not paid on time due to cash difficulties, however, the accrued

rent was paid early in 2019 and is deducted on this Form 990 for 2019.

other services to REC as well as other ministries and businesses throughout the Chattahoochee

and the costs incurred toward the net assets have been shown on Line 15 of Part X. A liability

of approximately \$100,000 was also assumed at a local bank. On January 25, 2019, the facilities

were purchased by the Archdiocese of Savannah, GA. The loan to the local bank was paid in

full, plus accrued interest, and the resulting gain on sale is shown on Section VIII.

Form 990, Part X, Line 25 On August 22, 2017, the Cottles had to make a short-term loan to

REC to cover necessary costs and expenses. A note was executed with a stated interest rate of

3.25%, the same rate that would have been charged by a bank. The note was paid in full, plus

Cottle, an only grandson, has helped tremendously and oversees the production and distribution

of the REC materials to churches and other groups worldwide. Additionally, Dr. Thomas Hale, a

dear friend of Dr. Cottle, has come on board to help in this endeavor. His IT ability and love

for Christ have proven to be a strong asset to formalize the teaching and preaching ministry

of Dr. Cottle. Late in 2019 at the annual Trustee's meeting, Rev. Hale and Roman were selected

to be board members while former members (Virginia Cornett and Gloria Thomas) transitioned

off the board.

Form 990, Part VIII, Line 1 In 2019, REC Ministries was approached by Shashi Bhandari, a

believer and a citizen of Nepal. Shashi had spoken several times in America in order to raise

funds for his ministry in his home country. After Shashi received permission from Nepal

authorities to initiate his ministry, open a bank account, etc., REC decided to place the

Nepal ministry under its spiritual covering and be the conduit of funds given by those living

in America and periodically transfer those funds to the ministry account in Nepal.
