("NRCCUA") in the amount of \$729,380 will not be paid. The amount relates to prior year advances from NRCCUA to fund operating deficits. The balance has not changed since 2017. The organization's president disputes the amount is owed to NRCCUA and maintains that any amounts funded to the organization were to offset survey services that were provided to NRCCUA by the organization for which the organization has not been compensated. Several attempts have been made by the organization to contact NRCCUA to resolve the outstanding balance. NRCCUA was acquired by ACT, Inc. in July of 2018. NRCCUA has changed CFOs three times in the last 4 years and has had two presidents in 3 years. Nobody from NRCCUA/ACT has returned the president's telephone calls, letters and emails. As such, the liability has been taken off the balance sheet and is reflected as income for 2019 on Part VIII.
