Coolidge Senators Program -- The Coolidge Senators Program honors the top applicants to the Coolidge Scholarship by hosting them at the annual Coolidge Senators Summit in Washington, DC. The students remain engaged with the Coolidge Foundation through the Coolidge Senators Network.
