The organization conducted various functions for members to celebrate and promote Polish and non-Polish members traditions and customs. These functions included free meals and entertainment. Functions and related expenses were as follows:

- A dinner-dance was held to celebrate Polish Heritage Day. (\$1335)

- A scholarship awards breakfast was held for the families and friends of scholarship recipients. Scholarship awarded totalled (\$2900) Breakfast buffet cost (\$212)

- A May Day celebration was held to observe Polish Constitution Day. This event included a flag raising at City Hall with guest speakers presenting historical information how the Polish People settled in America. A meal followed in our function hall (\$1955).

- A Membership Appreciation Day was held. This is a day long event where members and their families join the organization for a day of food, games, crafts and entertainment followed by an evening dinner for the adult membership. (\$2272)

- A Memorial Day cookout is held for all members and their guests in appreciation to our current military members and deceased veteran members. (\$589)

Our organization offers the use of the meeting room/function area to other organization and groups free of charge.

These groups and uses are as follows:

- The local Polish American Veterans uses the facility for monthly organizational meetings, semi annual membership meetings, a turkey-day where turkeys are handed-out to the needy and a Sun-Santa Day where gifts are collected for the local Christmas-Gift-Drive.

They also observe Memorial Day which includes a flag raising/Taps playing and wreath dedication to all veterans and deceased veteran members.

- The Lowell Polish Cultural Committee uses the facility for quarterly organizational meetings and historical lecture presentations. These presentation include guest speakers and a group of individual that discuss Polish history, traditions and customs.

The facility is also used used as their home-base for planning and preparation for participation in the yearly Lowell Folk Festival.

The facility kitchen is used to prepare foods that are sold at the 4-day Festival.
