Southeast Asia: We work in two of Cambodia's globally significant forests, Prey Lang and the Cardamoms, and partner with the indigenous Kuy people, local communities, and government agencies to protect critical forest areas and at-risk Asian elephant populations in ways that support traditional livelihoods and regional prosperity. We are also working to develop Cambodia's newest marine protected area in Kampot province that includes mangrove forests, sea grass beds and coral reefs. Key achievements this year include: 1) We constructed a new field station to improve ranger response in Prey Lang; 2) Using results from our biological monitoring we advised the government on conservation zoning and reported on illegal wildlife trade and other key threats in Prey Lang; 3) Our team trained See Part III, Ln 4a statement

Africa: Our mountain gorilla conservation efforts in Central Africa span more than 20 years and we now use these lessons to help turn the tide for critically endangered Grauer's gorillas in eastern Democratic Republic of the Congo. Together with the Congolese NGO Primate Expertise, we work in the upland sector of Kahuzi-Biega National Park and in adjacent indigenous Batwa communities. In Rwanda we partner with the women-led cooperative Imbereheza Gahunga to build household rainwater tanks, improving water access while eliminating the need to enter gorilla habitat. Key achievements this year include: 1) We report zero Grauer's gorilla deaths from poaching and at least seven new births in our project area since we intensified anti-poaching efforts in 2017; See Part III, Ln 4b statement

Americas: We continue to leverage more than a decade of success protecting marine turtles in the Eastern Pacific to support recovery of sea turtle populations in El Salvador. Together with Salvadoran partner ProCosta, we are working to restore the population of critically endangered hawksbill turtles at three sites in El Salvador, focusing on nest protection and hatcheries, community engagement and turtle monitoring and research. We also worked in Belize to identify, locate and assess Belize's tree species while building Belizean capacity in botanical research and conservation. Key achievements this year include: 1) We constructed two new hatcheries to increase hawksbill nesting success; 2) We trained 100+ members of the local hawksbill conservation See Part III, Ln 4c statement

species whose protection benefits broader biodiversity. Current priorities include  
Asian elephants in Cambodia, great apes in Central Africa, marine turtles in
