The Bureau received and evaluated 3,307 suspected insurance fraud referrals from the insurance industry, members of the public and other sources, of which 1,416 referrals were accepted for further investigation, resulting in 1,075 new investigative cases. After initial investigation, 707 cases were closed without criminal prosecution due to insufficient evidence of a crime.

The Bureau referred 234 cases to federal, state and local prosecutors during the year, and supported those prosecutors in the location of witnesses, witness interviews, delivery of subpoenas and additional investigation. 166 individuals were initially charged with insurance fraud and other crimes during 2019, and court cases involving 200 individuals reached a final disposition.
