Included in our general program activities in 2019 was our webinar series, a dynamic online program that provides educational opportunities to the general public on the diverse areas of expertise within the ELP Community and a multi-day Senior Fellows Retreat which brought together 20 Fellows from around the country and across program years.

RAY Fellowship Program: In 2019, ELP managed the Roger Arliner Young (RAY) Fellowship Program, a collaboration between the Ocean Conservancy, Oceana, PointBlue, National Resources Defense Council, the American Council for an Energy Efficient Economy and RARE. The RAY Fellowship is designed to increase the number of people of color working in conservation through a paid one-year fellowship for recent college graduates. In 2019, 5 new RAY Fellows were selected and placed within the partner organizations for a one-year fellowship and one 2017 RAY Fellow received a year long extension.
