Six young Nepali adults, most of whom lived in prison with a parent in their childhood are being sponsored by Foresight for their tertiary education. Their full school and living expenses are supplied by Foresight. They are part of a larger group of 20 young adults who have been part of this program over the past 13 years. The other 14 students have finished their bachelor programs and are employed. Most all of these 20 young adults continue to receive individual mentoring by Foresight staff, both in-country and remotely, to help them develop into responsible, contributing adults.

4b (Code:) (Expenses \$ 36,594 including grants of \$ 36,594) (Revenue \$ 0)

National Bethel Academy (NBA) is a school founded in 2008 in the town of Trishuli, Nepal by a team of church leaders and Foresight staff. The school is intentionally different from traditional Nepali education. In contrast to the traditional method of sheer memorization with shaming and corporal punishment, NBA emphasizes thinking, creative teaching, individual student attention, and respect for individual differences. The school has 315 students in grades Nursery to 10.

4c (Code:) (Expenses \$ 2,025 including grants of \$ 2,025) (Revenue \$ 0)

Ebenezer Bible College is a pastoral training center in Kathmandu which serves a consortium of Christian churches throughout the country of Nepal. \$1,400 of the funds went to their operational budget. Bethel Assemblies of God Church in Kathmandu also trains pastors for ministry and \$625 went for that purpose.
