We seek to promote natural, holistic and sustainable solutions to the challenges of poverty, malnutrition and disease by supporting orphans, providing scholarships, growing, producing and distributing herbal medicines and planting trees all over Mara region.

We have two tree nurseries that distributed 311,000 trees for free to individual farmers, schools, churches and government offices. We provide training in agroforestry to all beneficiaries. All activities take place in the Mara Region of Tanzania.

We support approximately 150 orphans in two related programs, one in Kinesi Village and one in Musoma town. We provide 22 kg of maize and 3.5 kg of beans to each foster family hosting orphans in the program. We also pay for all school expenses through secondary school and provide tutoring and counseling services to all the kids in the program.

We provided college scholarships or vocational training tuition for 41 kids who have graduated from secondary school. College scholarships include tuition, room and board.
