SOUTH AVENUE COTTAGE (AN ASSISTED LIVING FACILITY FOR 6 ADULTS WITH SPECIAL NEEDS), ABC HOUSE (A RESIDENCE FOR INNER-CITY YOUTH ATTENDING NEW CANAAN PUBLIC SCHOOLS), A-HOME (PROVIDER OF SAFE AND AFFORDABLE HOUSING FOR LOW INCOME OLDER ADULTS AND DISABLED INDIVIDUALS), STAR INC. (DAY SERVICE PROGRAM FOR ADULT WITH DISABILITIES), THE CHABAD JEWISH SUNDAY SCHOOL AND MOVERS AND SHAKERS PARKINSON'S SUPPORT GROUP AND GIRL SCOUTS OF AMERICA, NEW CANAAN CARES, NEW CANAAN COMMUNITY FOUNDATION, THE NEW CANAAN SQUASH CLUB, THE NEW CANAAN PARENT SUPPORT GROUP, FRIENDS OF NEW CANAAN SOCCER INC., THE ADA AND THE LIVEGIRL ORGANIZATION.
