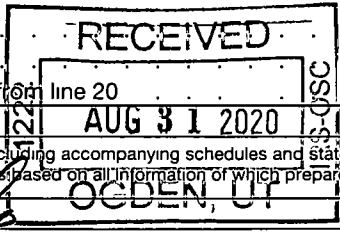

Relevance provides discipleship and service opportunities in the Corvallis area by offering space to other Christian and non-Christian organizations and for concerts, movies, and events. A Fellowship & Coffee group utilized the facilities most every week of the year. Encouraging missions, both domestically and abroad, and outreach locally is always a part of the program. Friends of Internationals activities encourage students to help others. Campus ministries utilized the facility to reach out to those living at OSU and/or going to school at LBCC. Informal Bible Studies and study groups met at the Courtyard through the year. With the increase of International students, efforts internally and externally, were focused on welcoming and building relationships via conversation corner, game nights, meals, activities and one-on-one assistance. In general, all people of any, or no, faith are welcome to participate in activities at the Courtyard. Our efforts to assist others in community service or in our programs like Halloween, Sweater Nogger, or oral English assistance and are open to everyone. The results are seen in hundreds of 'Courtyardians' alumni that continue to produce good works that they are created for "For we are God's handiwork, created in Christ Jesus to do good works, which God prepared in advance for us to do " Ephesians 2:10

4b (Code:) (Expenses \$ 252,895 including grants of \$) (Revenue \$ 312,108)
Relevance owns and operates the Courtyard (a 20,000 sq. ft. building) in Corvallis, OR, near Oregon State University. The purpose of the Courtyard is to provide an encouraging and economical living situation where up to 48 Christian collegiate men and women can be built up in their relationship with Jesus Christ and with one another. Toward this end, the Courtyard works at establishing an atmosphere of Christian fellowship and spiritual growth so that the scholastic, intellectual, cultural, social and athletic aspects of living may be pursued in ways honoring to the Lord. Courtyard residents are expected to participate in community service each school term, be in community with each others in solid Biblical teaching and worship, attend gender specific small accountability groups, and walk in a manner that is modeled by Christ and the entire Word of God. For 2019, there were hundreds of hours of community service done. The facility is run in a manner with residents being guided by a full-time paid women's director, a full-time men's director, and a chef. Each resident participates with acts of service (ministry) of chores that need to be accomplished for the benefit of all. The full-time chef provides meals for the residents during weekdays and for different events. "You will seek me and find me when you seek me with all your heart. I will be found by you," Jeremiah 29:13-14a

Although not associated with any one denomination, its mission is to work in collaboration with all churches to providing an environment for Christian students to sharpen their spiritual persons through discipleship and serving in the community and (B) by providing public teaching and activities that welcome the community in to see the relevance of Jesus Christ through courses. The Courtyard also offers other events that reach out to the community in the form of movies, concerts, and activities. Young Life and their leaders utilize the facility throughout the year for small gatherings or club meetings. Prayer meetings by groups from outside are welcomed into the Courtyard. Weekly meetings of women's fellowship met in different rooms of the Courtyard. Working together for unity.
