The Personal Wellness & Care Coordination Team will make regular visits at least annually to Members to identify any changes in health and functional status. When changes occur, arrangements will be made and, when covered by the Plan, will be provided at no cost to the Member according to the Plan options chosen at enrollment. Envisage in 2019 started to offer four additional membership plans

**ARTICLE I: NAME, EXISTENCE, AND REGISTERED OFFICE**

**A. NAME**

This Corporation will be known as ENVISAGE LIFE, hereinafter referred to as the "Corporation".

**B. EXISTENCE**

The existence of the Corporation will be perpetual. The Corporation is one which does not contemplate pecuniary gain or profit, incidental or otherwise. The Corporation is organized upon a nonstock basis.

**C. PRINCIPAL AND REGISTERED OFFICE**

The principal place of business and the location of the registered office of this Corporation shall be at 1215 Hulton Road, Borough of Oakmont, Allegheny County, Pennsylvania 15139.

The Corporation may also have offices at such other place as the Board of Directors from time to time appoint or the business of the Corporation may require.

**ARTICLE II: PURPOSES**

- A.** The Corporation is an established senior life-care community dedicated to enriching the lives of its members by providing an innovative plan for healthy adults, aged sixty (60) years and older, that combines the benefits of long term care coverage with the support of a personal wellness and care coordinator who helps members stay healthy, live independently and navigate the healthcare system. The Corporation is recognized by the Pennsylvania Department of Insurance as a Continuing Care Retirement Community. . The purposes of the Corporation are exclusively charitable as set forth hereby.
- B.** Subject to the law governing the operations of the Corporation, the net earnings of the Corporation may be distributed to its Members to further the charitable purpose thereof. None of the assets of the Corporation shall inure to the benefit of, or be distributable to its trustees, officers, or other private persons, except that the

Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in A. hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- C. Upon the dissolution of the Corporation, its assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### **ARTICLE III: MEMBERS**

- A. The Members of the Corporation (the "Members") will be Presbyterian SeniorCare ("PSC") with a ninety percent (90%) membership interest, AND Lutheran SeniorLife ("LSL") with a ten percent (10%) membership interest. The Members shall annually appoint the directors of the Corporation;
- B. Each Member of the Corporation must be recognized by the Internal Revenue Service as a 501(c)(3) organization and must continue to maintain such status or resign as a Member of the Corporation;
- C. A single director shall be appointed by each Member except that PSC shall be entitled to appoint the remainder of the Board of Directors in accordance with Article VI hereof;
- D. New Members of the Corporation shall be subject to the approval of PSC;
- E. A new Member of the Corporation shall be required to make a capital contribution to the Corporation in an amount determined by the Directors; and

F. Membership in the Corporation shall not be transferrable except with the approval of the Board of Directors.

#### **ARTICLES IV: POWERS RESTRICTED TO MEMBERS**

A. The following powers are reserved exclusively to the Members and no attempted exercise of any such powers by any persons or entity other than the Members shall be valid or of any force or effect whatsoever.

1. To determine or change the mission and to monitor and maintain the philosophy of the Corporation, and any subsidiary of the Corporation, joint venture, partnership, or other affiliation arrangement of the Corporation, by which it was formed and for which it exists;
2. To elect and remove with or without cause Directors of the Corporation, and to approve the election of Directors of any subsidiary of the Corporation, joint venture, partnership or other affiliation arrangement of the Corporation which will require the appointment of a Board; and to approve the election of Officers of the Corporation by the Board of Directors;
3. To amend, alter, modify or repeal the Articles of Incorporation and the Bylaws, and to approve any amendments, alterations, modifications or repeal of the Articles of Incorporation, and the Bylaws of any subsidiary corporation, joint venture, partnership, or other affiliation arrangement of the Corporation;
4. To acquire, purchase, sell, lease, transfer, or encumber, construct or undertake the destruction of property owned by the Corporation or in which the Corporation has or will have equitable or legal title having a value in excess of \$100,000, and to approve such actions as set forth in this section as they may apply to any subsidiary corporation, joint venture, partnership or other affiliation arrangement of the Corporation;
5. To dissolve, merge, consolidate, affiliate, or divide the Corporation and/or to merge, consolidate, or affiliate the Corporation with any other corporation or organization and to approve such actions as set forth in this section as they may apply to any subsidiary corporation, joint venture, partnership or other affiliation arrangement of the Corporation.
6. To approve any borrowing or other financial obligations not contained in the capital or operating budgets of the Corporation, and to approve such actions as set forth in this section as they may apply to any subsidiary corporation, joint venture, partnership or other affiliation arrangement of the Corporation;

7. To require an independent audit or review and to appoint the independent auditor of the Corporation annually;
  8. To approve any cash distribution to the Members;
  9. To approve the election of officers of the corporation or any subsidiary;
  10. To approve the appointment of independent auditors and legal counsel; and
  11. To approve capital and operating budgets of the corporation and any subsidiary.
- B. Exercise of the above powers shall require the written approval of PSC.

#### **ARTICLE V: RESIGNATION OF A MEMBER**

Loss of a Member's 501(c)(3) status shall result in forfeiture of such Member's Membership. A Member may resign its Membership upon 60 days' notice to the Corporation and shall be paid in such event such amount as determined by the Board of Directors.

#### **ARTICLE VI: POWERS OF THE CORPORATION**

The Corporation is empowered:

- A. To borrow money and issue evidence of indebtedness in furtherance of any or all of the objects of its business, and to secure the same by mortgage, pledge, or other lien on the Corporation's property; and
- B. To do and perform all acts reasonably necessary to accomplish the purposes of the Corporation.
