CHINA/CAPITAL MARKETS TRANSPARENCY INITIATIVE PSSI WASHINGTON LAUNCHED ITS CHINA CMTI ON MARCH 5, 2019. THIS PUBLIC POLICY EDUCATION PROGRAM WAS UNDERPINNED BY THREE YEARS OF INTENSIVE RESEARCH AND ASSISTANCE WITH THE PREPARATION OF A 105 PAGE REPORT FOR THE U.S. GOVERNMENT ENTITLED "NATIONAL SECURITY DIMENSIONS OF CHINA'S CORPORATE PRESENCE IN THE U.S. CAPITAL MARKETS." PSSI WAS THE WORLD'S FIRST NGO TO PURSUE SUCH AN INITIATIVE, FOCUSED ON HOW U.S.SANCTIONED AND OTHER CHINESE CORPORATE "BAD ACTORS" HAVE BEEN FUNDING THEMSELVES IN THE U.S. DEBT AND EQUITY MARKETS FOR SOME 20 OR MORE YEARS WITH THE INVESTMENT CAPITAL OF SCORES OF MILLIONS OF UNWITTING AMERICAN RETAIL INVESTORS.IN THE PERIOD SINCE ITS LAUNCH, THIS ISSUE HAS BEEN CATAPULTED TO THE PRESIDENTIAL LEVEL AND ENGAGED A SIGNIFICANT PORTION OF THE CABINET WITH FOREIGN POLICY AND NATIONAL SECURITY DUTIES. FOR EXAMPLE, PSSI WASHINGTON'S EXECUTIVE DIRECTOR, ROGER ROBINSON, WAS SINGLEHANDEDLY RESPONSIBLE FOR DISCOVERING AND LEADING THE OPPOSITION TO CHINESE CORPORATE BAD ACTORS BEING ADDED TO THE LIST OF INVESTMENTS OF THE FEDERAL THRIFT SAVINGS PLAN. THE PRESIDENT DIRECTLY INTERVENED TO TERMINATE THIS PLANNED ACTION. THERE HAVE BEEN NUMEROUS OTHER HISTORIC ACCOMPLISHMENTS THAT HAVE BEEN COVERED BY THE MAINSTREAM MEDIA.

THERE HAVE BEEN FIVE LARGE CONFERENCES CONVENED TO DATE IN PRAGUE, WASHINGTON DC AND TOKYO. OVER THE COURSE OF 2019, PSSI CONDUCTED A LENGTHY STUDY ENTITLED "STATE ACTOR STRATEGIES IN ATTRACTING SPACE SECTOR PARTNERSHIPS: CHINESE AND RUSSIAN ECONOMIC AND FINANCIAL FOOTPRINTS."
