THE IMNF IS THE ONLY ONE OF ITS KIND IN THE UNITED STATES. IT IS EXPANDING THERAPEUTIC MORALITIES FOR TREATING PATIENTS WITH STROKES AND OTHER NEUROLOGICAL CONDITIONS. IMNF USES MUSIC THERAPY TO ASSIST THOSE WITH MEMORY DEFICITS, MOTOR REHABILITATION NEEDS, AND SPEECH THERAPY.
