PUBLIC BENEFITS: - WORKING WITH A BROAD COALITION OF ADVOCATES, MCJ PROVIDED LEGAL MATERIALS TO THE LEGISLATURE AND SUCCEEDED IN GETTING A PROVISION IN A CRIMINAL JUSTICE REFORM BILL THAT OPTED OUT OF A FEDERAL LIFETIME BAN ON SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) AND TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) BENEFITS FOR DRUG FELONS. THE NEW LAW, WHICH WENT INTO EFFECT IN JULY, 2019, PROVIDED POTENTIAL ELIGIBILITY FOR SNAP AND TANF TO OVER 90,000 MISSISSIPPIANS. FOR THE 2020 SESSION, MCJ DEVELOPED 174 FACT SHEETS ON FOOD INSECURITY FOR EVERY STATE LEGISLATIVE DISTRICT, POLICY BRIEFS, AND OTHER ADVOCACY MATERIALS TO POWER POLICY ADVOCACY TO PROTECT AND STRENGTHEN FOOD ASSISTANCE PROGRAMS AND CULTIVATE HEALTHY AND JUST FOOD ACCESS FOR ALL. WE HAVE PRODUCED A WHITE PAPER AND EDITORIAL PROMOTING THE ELIMINATION OF THE GROCERY TAX. - AS PART OF ITS EFFORT TO BUILD A STATEWIDE NETWORK OF COMMUNITY MEMBERS AND ORGANIZATIONS THAT WILL WORK TOGETHER TO END HUNGER AND ADVANCE FOOD SECURITY IN MISSISSIPPI, MCJ ORGANIZED GRASSROOTS REGIONAL MEETINGS IN SIX AREAS OF THE STATE, BUILDING A LIST OF MORE THAN 100 INTERESTED INDIVIDUALS AND ORGANIZATIONS TO LEARN FROM EACH OTHER AND ADVOCATE TOGETHER. ALONG WITH FEEDING THE GULF COAST, WE ESTABLISHED A SNAP WORKGROUP WITH THE DEPARTMENT OF HUMAN SERVICES, PROVIDING A REGULAR FORUM FOR EXCHANGE OF IDEAS AND SUGGESTIONS FOR SNAP IMPLEMENTATION IN MISSISSIPPI. WE BEGAN A SNAP NOTICE REVISION PROJECT WITH DHS TO MAKE SNAP NOTICES MORE USER FRIENDLY. - WE WORKED WITH A MASTER OF PUBLIC HEALTH (MPH) STUDENT TO CONDUCT A GIS ANALYSIS EXAMINING THE RELATIONSHIP BETWEEN REDLINING, FOOD APARTHEID, AND RESULTING HEALTH INJUSTICES IN JACKSON, MS. THE ANALYSIS AIMS TO CHARGE THE NARRATIVE AROUND FOOD INSECURITY IN JACKSON TOWARD ACKNOWLEDGING AND DIRECTLY ADDRESSING ROOT CAUSES THROUGH EQUITABLE, COMMUNITY-DRIVEN POLICY CHANGE. WE ALSO PARTNERED WITH THE CITY OF JACKSON'S BLOOMBERG PHILANTHROPIES-FUNDED FERTILE GROUND PROJECT TO HELP CRAFT POLICY SOLUTIONS TO FOOD APARTHEID IN THE CITY. OTHER WORK: - MCJ SCHEDULED BUS TRIPS FOR HIGH SCHOOL JUNIORS AND SENIORS FROM AROUND THE STATE TO THE MISSISSIPPI HISTORY AND CIVIL RIGHTS MUSEUMS. WE COORDINATED 105 BUSES FOR HIGH SCHOOL JUNIORS AND SENIORS FROM ALL OVER THE STATE. EACH TRIP WAS GUIDED BY A VETERAN OF THE CIVIL RIGHTS MOVEMENT.

THE SECOND YEAR OF THE PROJECT INVOLVES IMPLICIT BIAS TRAINING FOR SCHOOL PERSONNEL AND ANALYSIS OF DISCIPLINE STATISTICS.
