Community Safety Awareness programs provides basic life saving skills such as basic and advanced CPR, AED, First Aid, Earthquake Preparedness and Communicable Disease training. The Typical student population we address is low income and less educated. Research has shown a greater number of issues occurring in these populations than ones with more educated people. This program related to the ASHA program in that it teaches social responsibility and assists in helping people to work together to solve common issues.
