TWENTY-THREE CHAPLAINS REPRESENTING FIVE FAITH TRADITIONS VISITED HOSPITAL PATIENTS, NURSING HOME RESIDENTS AND CORRECTIONAL FACILITY INMATES AT SEVEN LOCAL FACILITIES.- BEAUTIFICATION THROUGH INTERFAITH DIALOGUE (BTID) BUILDS BRIDGES OF UNDERSTANDING AMONG DIVERSE FAITH GROUPS, YOUTH, ADULT ALLIES AND SERVICE PROJECTS. BTID ACHIEVES THIS GOAL THROUGH THE PROCESS OF TRAINING, DIALOGUE, COMMUNICATION AND INTERACTION. AFTER RECRUITING EIGHT FAITH COMMUNITIES (TEMPLE CONCORD, ISLAMIC SOCIETY OF CNY SYRACUSE MOSQUE, THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS, CONGREGATION BETH SHOLOM CHEVRA SHAS, SYRACUSE SOUTH ASIAN FELLOWSHIP, BAPS SHRI SWAMINARAYAN MANDIR, DESTINY CHRISTIAN CENTER AND MASJID ISA IBN MARYAM), A KICK-OFF MEETING GATHERED PARTICIPATING FAITH LEADERS AND THEIR VOLUNTEERS FOR TRAINING TO HELP YOUNG PEOPLE TO LEAD DIALOGUE CIRCLES AT THE VARIOUS FAITH COMMUNITIES.- BUILDING UNITED COMMUNITIES (BUC) INTEGRATES NEW AMERICANS/REFUGEES WITH ESTABLISHED AMERICAN CONGREGATIONS. BUC UTILIZES SUSTAINED DIALOGUES, AN INTEGRATION FRAMEWORK AND A LEARNING COMMUNITY. INTERFAITH WORKS DEVELOPED A CUTTING-EDGE CHURCH INTEGRATION FRAMEWORK TO SERVE AS A MODEL FOR THIS PILOT PROJECT. THERE WERE NINE VISITS TO FAITH COMMUNITIES AND SCHOOLS, PART OF THE EFFORT TO EDUCATE AND EXPOSE CONGREGANTS AND STUDENTS TO REFUGEES AND THEIR RESETTLEMENT. THE PURPOSE WAS TO INCREASE KNOWLEDGE, COMPASSION AND ACTION ON BEHALF OF REFUGEE RESETTLEMENT EFFORTS. THROUGH THE OPPORTUNITIES CREATED BY THE SPIRIT OF AMERICA PROJECT, MORE THAN 1,000 LOCAL RESIDENTS WERE REACHED AS NEW AMERICANS SHARED THEIR STORIES OF REFUGEE RESETTLEMENT.

THIS AGE-FRIENDLY CLASS ADDRESSES THEBARRIERS OLDER ADULTS OFTEN FACE WHEN LEARNING ENGLISH, INCLUDING TRANSPORTATION, PHYSICALLIMITATIONS AND MENTAL HEALTH CHALLENGES. ELDERS ENROLLED IN THE CLASS BENEFITED FROM THE INCREASEDOPPORTUNITIES TO SOCIALIZE AND LEARN WITH PEERS. ELDERS ALSO ENJOYED FIELD TRIPS TO CULTURAL ANDRECREATIONAL SITES THROUGHOUT CENTRAL NEW YORK, INCLUDING THE EVERSON MUSEUM OF ART, THEROSAMOND GIFFORD ZOO, A PUMPKIN PATCH AND A HORSE FARM. WITH KEY PARTNERS, SENIOR SERVICES ESTABLISHED THE ONONDAGA COUNTY AGING SERVICES COALITION, TOBUILD CAPACITY TO ADDRESS SENIOR ISOLATION THROUGH A RACE- AND POVERTY-INFORMED LENS.
