THROUGH THE WRAP AROUND AND BREAK THE CYCLE OF POVERTY PROGRAM, PARENTS AND THEIR CHILDREN IN OUR SHELTER WILL HAVE ACCESS AND ADDRESS EACH OF THE 26 DOMAINS IN THE MATRIX THAT WE FOLLOW UPON ENTERING OUR NETWORK.
