The total value of the grant is \$150,000. The grant is a reimburseable grant. All expenses must be paid and documented before they are reimbursed. The difference between the cash received (144109) and expenses (140136) is timing only and would be from expenses claimed in 2018 but not reimbursed until 2019.

Provided classrooms of Delaware County Schools merchandise and supplies in the amount of \$544696.
