Peruvian Hearts scholars program provides 33 impoverished girls in Peru with full educational scholarships to attend university prep academies and 5-year college/universities, while also providing our scholars with access to mentors, opportunities to participate in community service, regular empowerment classes, and leadership workshops. The girls we support come from poor families with very limited economic resources and all of them have dealt with extreme hardship. In addition to academic scholarships, we provide our scholars with access to regular medical exams and cover any healthcare costs while they are in the program. We give our scholars access to a program psychologist, academic advisor, personal and professional mentors, and civic and community leaders. We put a particular emphasis on the personal growth and character development of each of our scholars, in addition to finishing their degrees at university.
