Part II, Lines

The organization has a program called Extreme Team. The Extreme Team committee receives requests from local not-for-profit organizations for help repairing and upgrading facilities.

The committee evaluates each request, conducts research into the organization, then determines which fit within the extreme Team program. Need and economic resources are evaluated in each case. And, in many cases, the not-for-profit contributes to the upgrade/repairs provided by the Extreme Team since the Extreme Team has a large cadre of skilled volunteers and can usually obtain building and landscape materials at cost. Records are maintained as to what each not-for-profit received, including a detailed video recording.

Part III Line 1: Winter Coats - The organization has a program called Coats for Kids. We collect gently used coats from the community, have them dry cleaned, then give them out to disadvantaged individuals. Cash donations are used to purchase NEW coats, after evaluating what age groups were under-served with donated coats. Distribution of the coats is supervised by licensed local community centers who evaluate recipients for proper need and control the distribution. Records are maintained as to coats received and distributed to each center.

Part III Line 2: Christmas Gifts - The organization has a program that provides disadvantaged families with "Christmas Wishes". The committee solicits and receives nominations from the community as to families struggling to provide for their children. The Christmas Wish committee considers the need and economic resources of the family nominated, and performs various checks to ensure eligibility. Records are maintained of the nominations, what each family was awarded in toys/grocery gift cards/etc, and the value of each Christmas Wish given.
