28 Services provided by a team of 6 people include logistical and administrative support at an executive level as well as executive level coaching to Bishops and church leaders Friends for the Future also executes the formation of lay leaders, aids in communications and resource development necessary for the execution of the strategic plan Our organization has been able to train and form a team of 7 people to make on-site visits to each parish once a month to help with implementation of the strategic planning process The team consists of 5 priests, 1 deacon and 1 lay woman working alongside the priests in each parish for foster renewal of the parish and the church As a result of the above mentioned services, the Diocese has 13 seminarians in formation which is a ratio of 1 3 per 38 parishes Two men are scheduled to be ordained to the Priesthood in June 2020, 2 scheduled to be ordained to the transitional diaconate, and 2 will be ordained permanent deacons in May 2020 The church has been presented in a consistent, relevant, beautiful, high-quality manner over 15 6 million times in the last 3 years to a significant number of people in this diocese and even more around the world Some significant stats include 2 million page views on our diocesan website by 243,000 users, 4 6 million video views on our diocesan Facebook Page, and a Facebook total reach of 13 3 million with 34,600 followers (The total number of 15 6 million does not include our email campaigns or Google & Yelp photo views of our churches, which easily total a few million more)In addition and because of the strategic planning process administered by Friends for the Future in conjunction with the Diocese of Houma-Thibodaux, 34 of our 50 priests have attended a course in leadership Adult formation is beginning to take hold through an eight week online video course, that is ongoing and continual (Grants \$ 22,955) If this amount includes foreign grants, check here . . . ☐	28a
