IN 2019, 123 BOOKS WERE SUBMITTED BY PUBLISHERS AND AUTHORS FOR CONSIDERATION. WINNERS ARE ANNOUNCED ON EARTH DAY AND THE ANNUAL AWARD CEREMONY IS HELD AT OUR READ GREEN FESTIVAL IN THE FALL. NATGEN ALSO BRINGS AUTHORS INTO AREA SCHOOLS AND DONATES HUNDREDS OF BOOKS TO TITLE I SCHOOLS. SEED GRANTS: SUPPORTS NATGEN'S ONGOING EFFORTS TO ENGAGE AND INFORM YOUTH ABOUT STEM, ENVIRONMENTAL LITERACY, AND SCIENCE-BASED TRUTH NATGEN AWARDS IN GRANT FUNDING TO 10 ENTITIES ACROSS THE UNITED STATES. GRANTS WERE AWARDED TO SCHOOLS, MUSEUMS, LIBRARIES, AND NONPROFITS TO IMPLEMENT THEIR WINNING PROJECTS. THE PROJECTS SHOW INNOVATIVE WAYS TO PROVIDE HANDS-ON ENVIRONMENTAL OPPORTUNITIES FOR YOUTH AND DISTRIBUTE NATGEN'S GREEN EARTH BOOK AWARD BOOKS. OUR WINNERS ARE SCHOOLS, LIBRARIES, AND MUSEUMS FROM VIRGINIA, MARYLAND, TENNESSEE, ALABAMA, LOUISIANA, NEW YORK, FLORIDA, AND KENTUCKY.
