We coordinate art teachers and their students to exchange artwork with children around the world to promote international kindness, peace, and friendship. This is our organization's single focus, and every dollar we receive and spend is for this sole activity. In 2019 we coordinated approximately 35,000 students in the USA to exchange artwork with children in Bangladesh, Philippines, Malaysia, Jordan, Pakistan, Afghanistan, Nigeria, and Peru. Grants totalling \$73,547 were given to the children's organizations that partnered with us in those countries to support their coordination and expenses.

Nearly all of our revenue comes from the American teachers, students, and schools that participate, as we generally request \$10-15 per student to cover our expenses

PAGE 1: We would like to update you on a few differences you may notice in our 2019 return compared to previous years.

First, please know that our funding model remains the same: we invite American schools to exchange artwork with children around the world, and we request a small contribution of \$10-15 per student from each American school to pay for the international delivery of the artwork. Until now we have reported all of these \$10-15 contributions together as "contributions and grants."

However, after a thorough review, we have learned that many of our participating schools record these contributions to us in their own financial records as payments for educational services rather than donations. Therefore, in order to more accurately categorize this revenue ourselves, we are now reporting all of the money we receive from schools as "program service revenue" rather than "contributions and grants."

This change has led us to switch our "Reason for Public Charity Status" on Part I of Schedule A from #7 to #10, given that this program service revenue is related to our exempt function. Meanwhile, we are only reporting "contributions and grants" for the donations we receive from individual supporters who are separate from our participating schools.

We are also changing the way we count "volunteers." In previous years we have always counted all of the high school students who create artwork in our programs as volunteers, which led us to report 25,000 volunteers for 2018. Now we will consider such students to be the "participants" in our programs, and we will reserve the term "volunteer" for any adult who volunteers to support our mission. This has led us to report 300 volunteers for 2019.
