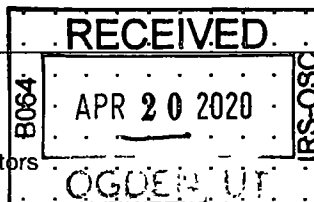

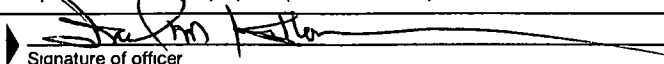

Meals are prepared & served 3 days p/week to low income people. Average number served is 35 p/week. Nutrition is stressed with emergency food available as needed.

Part III, Line 30 - Utility/Housing/Medical Payments

Assistance is provided to low income people to avoid losing critical utilities. Also, in order to prevent homelessness, motel bills are paid with prescriptions for medicines. Number helped in 2019 was 247.
