Urist McCauley spends over 90% of his time serving as Head Mentor performing non-administrative functions including being on call 24/7 for scholar emergency needs, transport scholars during emergencies, contact scholar families if medical situations occur, notify teachers of scholar's illness, review scholar schedules and coordinate with University Financial Aid Departments for resolution on payments and admission, drop/add, medical withdrawals, assist scholars in registering and obtaining housing, budgeting, meal plans, special nutrition, assess scholars' need for clothing, tutoring, counseling, coordinates transportation for attendance at Foundation events, job interviews, coops, confirm compliance with Smith Scholarship Foundation guidelines and work with Executive Director on warning probation, termination and reinstatement of students within the program, and works with co-mentors on campus visits and oversees student team leaders inclusion and accountability activities at each campus. Job Description – Linda Stewart

Linda Stewart's responsibilities include both administrative and mentoring functions. Her administrative functions include financial bookkeeping for the Foundation and oversight of independent contractors engaged by the Foundation. As a mentor, Linda assists students with securing books, lab supplies, professional clothing, and medical assistance, and providing transportation for Smith Scholars to attend college registration and seminars. She assists scholars with financial transactions, training – fiscal responsibility and monitors scholars' financial needs while students are participating in study abroad programs as well as overseeing emergency funding crisis intervention for students without family support. She has direct responsibility for securing housing, special supplies, and accommodations from University personnel and vendors on behalf of Scholars with physical disabilities and maintains personal oversight of disabled student's needs both at undergraduate and graduate levels.

1. College Scholarships

Scholarships are awarded to over 65 Alabama students to attend qualified institutions at the undergraduate and graduate level. Scholarships, grants, and loans are provided to recipients required to maintain accountability and strict program guidelines of academic, counseling, professional training, continued volunteer, and community service. Notable accomplishments include graduation and perseverance rates that exceed national averages for scholarship recipients of need based, first generation or at-risk students.

2. Mentor and Counseling Program

Low income first-in-family students require more than financial assistance to succeed in college. Studies demonstrate and SSF past experience confirms our student demographic need mentors. Each student receives 24/7 access to staff members who assist in academic issues, financial aid, registration, class selection, securing accommodations during school attendance, holiday breaks, employment, medical issues, tutoring, personal life management and life coach advice. With this support SSF scholars with little emotional or financial family support succeed because the mentor assistance program instills both academic and personal success far beyond the classroom.

Mental Health Wellness Initiative

SSF guidelines have long required recipients to engage in mental counseling. In particular, low to moderate income families and communities of first-generation college students lack needed mental healthcare due to financial resources, stigma, and culturally imposed values. After relying on school and community health programs, SSF established The Mental Health Wellness Initiative with a third-party counseling service to provide one-on-one counseling sessions for scholars who needed access to high quality, convenient and predictable care. The Mental Health and Wellness needs of students are necessary to attain the SSF mission of allowing students to become productive student leaders by addressing mental health issues arising from generational dysthymic family and social insecurity arising from unstable relationships burdened with poverty, abuse, lack of healthcare, discrimination, and multiple socioeconomic disadvantages. The mental health counseling has been successful in identifying and treating existing scholar mental health diseases including anxiety, depression, PTSD, bi-polar, and schizophrenia disorders. Treatment has helped many scholars obtain emotional stability needed to maintain academic progress and job opportunities.

3. Internships and Academic Enhancement and College Preparatory Programs

Seminars for both academic and leadership success are necessary to prepare underprivileged and first in family students for both successful college experiences and training necessary to obtain professional employment or graduate school opportunities. Freshmen attend "boot camp" orientation to prepare for college life, study skills, scheduling, budgeting, work study, and social situations that are new to SSF students. Upperclassmen serve as Team Leaders assisting in the transition to college and dorm room life. Academic and dorm supplies are furnished at the seminar as recipients do not have financial ability to secure these items. Professional seminars prepare scholars for internships and include networking, development, resume writing, interviewing, dining etiquette, professional attire is provided in addition to assistance in obtaining internships and job placement. These services have allowed SSF scholars to obtain both higher grades and graduation rates than national averages and transition into professional working environments and continue into graduate or professional programs independently with academic proficiency and emotional maturity. SSF graduates pursue and obtain post graduate degrees at a higher rate than national averages for their peers.

4. Scholarship Recipients Student Housing Expense

Secure and safe housing are key factors in maintaining low income students in a scholarship program. The Smith House provides a home for select Smith Scholars attending universities in the Birmingham area and visiting scholars enrolled in the SSF Program who face housing insecurity due to homelessness, abuse or lack of family support during dorm closures and holidays. The House also provides residency for internships allowing scholars to engage in both paid and unpaid internships and fellowships as well as volunteer and service opportunities required under SSF Guidelines. Residents residing in this facility have maintained honor grades due in large part to the stability and security provided at the House.

High school seniors and select outstanding Smith Scholars entering graduate or professional school to attend higher educational institutions as assigned with consideration given to student's personal choice, intended major, and other financial aid and scholarships as well as family circumstances impacting need to distance student from distractions, abuse or over-burdensome family issues. Undergraduate applicants must have a minimum C average in high school courses, verified by official transcript. Special preferences are given to those who are first in their families to attend college. Relatives of employees and officers serving the Foundation are not eligible for awards. Recipients must attend Foundation-sponsored seminars, workshops, training sessions/cultural events, accountability and team meetings, maintain grade point averages, submit verification of continuing volunteer work (52 hours annually)(and attend tutoring and advancement programs offered by the recipient students' colleges and Foundation to maintain and renew their awards annually.
