Our staff plus a team of volunteers monitor the issuance of grants to the persecuted or displaced Christians and others that we help in the Middle East and North Africa. They make monthly reports to Endure International's president in the USA to report how the grants were used that month. The staff and volunteers meet regularly with grant recipients to assess their needs, pray with them, counsel them, and assist them in other ways.

Part I Question 3 - Activities per Region

We have a total of 9 offices and 27 employees in the Middle East and North Africa. While the various offices and employees sometimes have specialties where they do the bulk of their work, they each do all of the five ministry activities at various times. They all work together to minister to the needs of the Christians in the Middle East and North Africa in whatever ways the Lord presents to us and provides to us the skills and resources that we need.

We have 1 office and 1 employee in Europe. Our ministry there is primarily to refugees from the Middle East.

As described in the notes about question 3 in part I, our team of staff and volunteers work with many individuals and families.

While we help many of the same people for multiple months, the specific people that we help changes from month to month.

We reviewed the monthly reports and believe that 190 is a very close estimate of the total number of individuals and families to whom we provided grants in 2019.
