WALK FOR BLADDER CANCER - THE WALK TO END BLADDER CANCER IS PART OF AN AWARENESS CAMPAIGN WHICH PRIMARILY TAKES PLACE IN MAY. THESE EVENTS UNITE BLADDER CANCER SURVIVORS, LOVED ONES, AND THE MEDICAL COMMUNITY TO PROMOTE RECOGNITION AND UNDERSTANDING OF THE DISEASE. IN 2019, WALK EVENTS WERE HELD IN OVER 25 COMMUNITIES NATIONWIDE. THE OVERALL AWARENESS INITIATIVE REACHED MORE THAN 4.3 MILLION THROUGH THE WEBSITE, MAILINGS, DIGITAL ADVERTISING, PROMOTION AND OUTREACH. THE EVENT INCLUDES A HEALTH WALK, SURVIVOR RECOGNITION AND EDUCATION ABOUT THE SIGNS AND SYMPTOMS OF BLADDER CANCER. MANY WALK PARTICIPANTS ALSO RAISE ADDITIONAL FUNDS TO SUPPORT BCAN'S MISSION PROGRAMS. THE WALK FOR BLADDER CANCER IS HELD IN MAY AS PART OF BLADDER CANCER AWARENESS MONTH. ADVOCACY - AS THE VOICE FOR THE PATIENT COMMUNITY, BCAN PARTICIPATES IN COALITIONS AND WORKS WITH OTHER MEMBERSHIP GROUPS TO WEIGH IN ON POLICY ISSUES THAT DIRECTLY IMPACT THOSE LIVING WITH BLADDER CANCER.
