THE PEER RECOVERY COMMUNITY CENTERS ARE WELCOMING ENVIRONMENTS WHERE PATRONS MAY ACCESS DIRECT PEER RECOVERY SUPPORT, MUTUAL-AID MEETINGS AND GROUP SUPPORT, TRAINING AND EDUCATIONAL WORKSHOPS, AND SOBER-SOCIAL ACTIVITIES AND EVENTS. THE PEER CENTERS ALSO OFFERS A RANGE OF OTHER AMENITIES COMPUTER LAB AND OTHER SUPPORT SERVICES TO HELP INDIVIDUALS NAVIGATE THEIR RECOVERY JOURNEY SUCH AS COMPUTERS, TRAINING ROOMS AND MEETING SPACES, RECOVERY BOOKS AND LITERATURE, RECYCLED CLOTHING AND BASIC HYGIENE SUPPLIES, BUS PASSES AND OTHER TRANSPORTATION ASSISTANCE, ETC.
