A variety of programs have been developed as needs are identified within the community. The organization determined that more than 300 low income elderly persons in the area required food assistance. In response, the organization prepares more than 300 meals per week that are delivered to seniors by volunteers. A Community Garden has been established. The Healthy Weekend program provides supplemental weekend food to 250 local children who qualify for free and reduced price meals at the school. Kids Cooking Camp helps youngsters learn to self-prepare healthy meals. A selection of breakfast foods are provided daily to students in the nearby Shields Valley School District, serving approximately 100 children.

The organization was originally established to provide food and assistance for persons and families in need. The area serviced is primarily Park County, Montana, an economically depressed and rural area near Yellowstone National Park. Many residents live at or below poverty level. The mission has evolved and expanded as more specific needs have been identified. Community programs continue to be developed to address these needs. Some of these programs provide meals to seniors and schoolchildren. The organization works with other local nonprofits and vendors to provide fresh locally sourced food to improve the nutrient value of foods distributed to pantry clients, and to support local farmers and ranchers. Another program provides training in culinary arts to prepare individuals for employment as restaurant and institution cooks.

More than 950 individuals, foundations and other nonprofits support the organization annually. In addition to the Food Pantry operations and support for community programs, the facility provides public meeting space and a commercial community kitchen. This further serves the mission in providing a licensed, well-equipped kitchen for local entrepreneurs to use to start or expand their business operations.

Donations do more than simply alleviate hunger - they make possible the evolving programs that identify and provide long-term, effective solutions that address specific needs, as well as tackle the issues of economic development, health care and education. Park County has recently suffered the loss of several government assistance programs, so the work being done by this organization is more vital than ever.

Food Pantry

During 2019, the Food Pantry provided food and supplies to approximately
700 people in need each month. Efforts are made to treat all
"customers" with respect in a grocery store setting. The staff strive to
identify other needs, and provide information as to additional resources
available from either this organization or others in the community. In-kind
donations of food and supplies are received from local grocery stores as
well as individuals. Other food and supplies are purchased at wholesale
prices. More than 85% of the food distributed is purchased with donated
funds. Matching grants are utilized. Bulk foods are often processed in the
commercial kitchen to provide nutritious fresh food to be distributed in
the Food Pantry or through the various community programs. Donations/grants
are received from individuals, foundations, and local churches. The Food
Pantry even addresses issues with special products for
new mothers, pets, and persons with special dietary needs such as seniors.

In late 2019, the Food Pantry raised in excess of \$145,000 to support
expansion of the bakery operations. In the past several years, the Food
Pantry has been baking its own bread and distributing it not just in the
Pantry, but selling the product locally. The local HRDC organization
donated a space a block away from the Pantry building, and approximately

\$70,000 was expended in 2019 for leasehold improvements and equipment. Operations commenced in March of 2020. In addition to providing a retail outlet (which funds are put back in to general funds to support Pantry and Community Program operations) for sale of the product, the expanded production capacity will enable the Food Pantry to provide fresh, nutritious breads for free to other pantries in Montana. One of the current food distributors has agreed to transport the products across the state. Future goals include potentially working with the women's prison in Billings to provide a halfway house, job, and professional training for recently released inmates to help them transition back in to being productive members of society. In the short-term, the bakery operation provides jobs, provides food, and provides funding to support other community programs.

Community Kitchen and Meeting Room Facilities

The building includes a commercial kitchen and a meeting room that can seat approximately 60 persons. The meeting room is rented at a nominal cost to other local and state nonprofits, as well as other customers. These meetings often include related catering, prepared by staff in the kitchen. Staff also process foods to be distributed through the Food Pantry, including baked goods, packaged fresh vegetables and meats, soups, stews, and other prepared meals for use in the Community Programs. Another use of the kitchen is in processing bulk orders for home-based businesses that require the certification of a commercial kitchen. The kitchen also addresses economic needs of the community, in that the local labor market is heavily dependent on food service - cooks and servers - and training
