This organization was a 501c3, 509a3 previously and changed to a 501c3, 509a1 in 2019. All operations as a supporting non-profit ceased on 3 September 2019 when the supported non-profit completed bankruptcy. Our organization was previously named AFWW Foundation. AFWW Inc. was the umbrella organization that we supported until 3 September, when AFWW Inc. completed the bankruptcy process. The facility where we operate was a CCRC until 3 September 2019. Our non-profit operates on donated household goods from residents or relatives of deceased residents and from cash donations. We exist to support the resident community and the surrounding community. Our sales operation sells the donated household goods referenced above. The Bankruptcy of the CCRC required the transfer of funds held under AFWW Inc. One of these funds was established by the Attorney General as a result of the bankruptcy and two others were scholarship funds held under the AFWW Inc. umbrella. (See schedule B for details of these funds) Altavita Village Community foundation was a supporting 501(c)3 of AFWW Inc. and used their EIN which causes confusion after bankruptcy. Due to the change in classification, some projects that were possible before the change were not permitted after AFWW Inc, bankruptcy.
