Restoration:The Conservancy engaged hundreds of volunteers to remove litter on MLK Day of Service outside the park during the federal government shutdown in January. It hosted the Regional Friends Alliance meeting in April & sharing park partnership best practices. It inspired volunteers to remove litter from 70 locations in Washington, DC & Montgomery County, MD for extreme Cleanup in April, helping to restore the entire Rock Creek watershed. It defended Rock Creek amidst expansion plans for I-495 & I-270 by rallying public outcry that successfully moved work along Rock Creek to phase two of the interstate project to allow additional time to consider environmental impact concerns.

It monitored water quality & litter as part of watershed collaborations with volunteers & regional environmental organizations. It conducted stormwater management through the Downspout Disconnection program, funded by DC Water, & a rain barrel program in Aspen Hill, MD made possible in part by a grant from the National Fish & Wildlife Foundation.
