Nonprofit VOTE worked in 2019 to help nonprofits engage their communities in voting and elections. We released our "Engaging New Voters" report documenting the positive turnout impact of human service nonprofits doing voter engagement. We hosted 13 free webinars reaching 2,400 nonprofit staff with legal how-to's, best practices, and planning tools. We worked with Habitat for Humanity, Feeding America, Alliance for Strong Families and Communities, and others to develop voter engagement toolkits and campaigns for their own networks. We led custom workshops for Nat'l. Urban League, YMCA, Youth Services America, NAMI, and many others. We directly supported local voter engagement efforts through our States Program. We also released the "America Goes to the Polls" report that lifted up positive election reforms like Same Day Registration and Vote At Home for boosting voter turnout. With related administration and development costs, total 2019 expenses come to \$540,168.

National Voter Registration Day (NVRD), a collaborative event managed by Nonprofit VOTE, is a day of coordinated media and field actions to raise awareness and help eligible voters get registered. We shattered records for an "off-cycle" election in 2019 with 54 major national partners and 4,083 community partners who collectively helped 473,725 voters register or update their registration. The event generated 27 major news stories, thousands of local news reports, and millions of social media engagements. It was the #1 trending hashtag on Twitter. We provided online toolkits and legal guides to partners, hosted 3 webinars that drew over 700 attendees, and mailed partners organizing kits with free event posters and stickers. Work also included post-event data collection, reporting/evaluation, and initial planning for 2020. With the NVRD share of administration and development costs, total expenses come to \$362,420.
