**Baal Dan raises money in the United States and then provides grants to projects in Asia, Africa, North & South America. Grants are allocated to orphanages, schools, charities, and grassroots projects that have been audited (personally visited) by a Baal Dan representative and meet certain requirements. Baal Dan works with these projects to best determine how to help these children in there care.**

In order for a project to receive a grant application, certain requirements must be met. A grant application is required annually for each project. This application requires, among other things, a statement of the projects purpose and goals along with a brief description of sources of funds. The grant requester agrees to use the funds provided by Baal Dan directly for the children it serves. It also agrees to provide written reports to Baal Dan as to the use of the funds as well as to maintain records and receipts for Baal Dan's review upon request. These projects selected for grants must allow unrestricted access to Baal Dan's representatives for purposes of project review, either through personal site visits, phone discussions, or e-mails. Also, grant requester must certify that it has not provided and will not provide support or resources to any individual or organization that advocates, plans, sponsors, engages in, or has engaged in any terrorist activity.

Once a grant request has been received, each request is reviewed and determined where the project is stable, reputable and in keeping with Baal Dan's purpose and goals. All grants over \$5,000 are approved by Baal Dan's Board of Directors. In most cases, funds are wired to the grant recipient.
