In 2019, Real Partners Uganda supported several projects, including (i) completion of a Boys Dormitory for use by portions of the Primary and Secondary Schools, (ii) the continuing operation of Career Opportunities Pathways for Recent Secondary School graduates, (iii) introduction of the Teach A Man To Fish program to assist TOLM in establishing entrepreneurial activities designed to lead to local sustainability and to enhance teaching, and (iv) the operations of a 14 level, 600 student school (Natural Seed Nursery, Primary and Secondary Divisions), including payment of salaries and other operating expenses of the Schools and TOLM.
