With the help of our volunteers over the years, we have been able to establish and maintain two children's soup kitchens in Mexico. One soup kitchen is in the neighborhood where our primary center is located in Nogales, Mexico, and the other is 8 hours further south in a town called Navojoa. These soup kitchens are open each week and provide a safe haven for the children in the area. We also support neighborhood activities such as soccer teams, guitar lessons, block parties and other community enrichment events. We also use this fund to help families who have emergency needs.

We had approximately 150 volunteers come stay with us at our center in Nogales this year. This money goes to cover food, lodging and transportation for these volunteers. From this fund we buy mattresses and kitchen supplies. We also use this fund to cover the cost of utilities for the center.

The volunteers mentioned above spend five days and nights with us in our center. Each day we take the teams out to perform service projects in the neighborhood. This money pays for cement, gravel, sand and other construction materials. It is also used for supplies for block parties and community enrichment events.
