

SAFETY & EDUCATION PROGRAMS

Education: Walking and biking education programs included: Youth 1-2-3 Instructor Training for adults. For youth, a Safe Walking and Biking program was presented at 22 schools throughout New Hampshire and reached 2,082 students. The program is funded by the Safe Routes to School program and administered by NH Dept. of Transportation. Developed and marketed new Bike Friendly Driver Class and held several introductory sessions. Wrote and distributed an information flyer on E Bike usage and regulations. **Safety:** Continue to provide resources both on our website and in our monthly e-newsletter promoting safety and riding and walking tips. Continued participation in several state safety commissions including the Highway Traffic Safety Committee and the State-wide Trails Advisory Committee. Assisted with distribution of the state-wide Survey that contributed to NH Ped-Bike Plan.

RECYCLED BICYCLE PROGRAMS

Bike-Walk Alliance supports and encourages organizations around the state to provide bicycles at low or free rates to persons who would like the opportunity to improve their overall health and/or those who need a bicycle as a means of transportation. BWANH supports the development of new outlets for this service and participates in marketing these organizations by sharing their contact information on our website as well as featuring articles in our monthly e-newsletter. Income from the sales of recycled bicycles is used to advertise and provide funds to buy replacement parts and accessories. BWANH, through affiliate Bike-MHT, helped establish a Bike-Share program in Manchester, NH.

RAIL TRAIL DEVELOPMENT & MAINTENANCE

Rail trail development remains a strong component of BWANH's mission. We continue to support Friends of Salem Bike-Ped Corridor in their expansion and maintenance plans. NH Rail Trails Coalition is dedicated to improve safety on rail trails as well providing information on the 40+trails in NH, crafting legislation and with state committees. A state-wide Rail Trail Conference was held in November 2019 and was filled to capacity.
