ACBS held an annual conference to educate psychologists in the area of Acceptance and Commitment Therapy (ACT), Relational Frame Theory (RFT), and Contextual Behavioral Science, in Dublin, Ireland, in June 2019. The conference was organized by the ACBS Board, Executive Director, staff, and volunteer committees. This conference served to advance the science of psychology through a forum of presentations, workshops, and discussions. It aided psychologists and other mental health professionals in understanding principles that can be used to help their patients/clients. This conference drew approximately 1098 attendees from around the world. This activity was funded through conference registration fees.

ACBS maintains a website that serves to support the interaction between, and the education of, psychologists, students, and the public interested in contextual psychology/science, particularly ACT and RFT. This website helps to disseminate education resources among ACBS members as well as the general public. There were over 8300 website/ACBS members at the end of the 2019.
