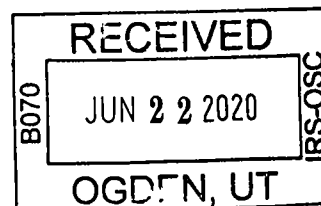

Shiloh University offers its educational programs at a lower tuition rate to allow for those who would not otherwise afford an accredited Bible college or seminary degree. Donations are solicited to help cover the costs of operating accredited degree programs. In the long-term an increase in enrollments is planned to cover most of the operating costs, while donations will continue to be solicited. There were 229 enrollments in the 2018-2019 academic year.

Part VI line 4: Shiloh University was formed in 2006 as a 501(c)(3) organization for the purpose of providing Christian higher education. The  
original Articles of Incorporation and Bylaws had the Shiloh University corporation subject to the another non-profit religious corporation.

The governing board of Shiloh University was selected by Apostolic Company. Therefore Shiloh University was considered an  
auxiliary entity of Apostolic Company and not subject to filing form 990. In April 2019, Restated Articles of Incorporation were filed in the  
state of Iowa. These restated articles removed the control of Apostolic Company, and established the Shiloh University governing board as  
an independent self-perpetuating entity. Revised Bylaws were also drafted and approved that removed all outside control of Shiloh  
University. In December 2019 a form 8822-B was filed reporting both a change in business location as well as a change in reporting  
requirements - for now a form 990 is required. This form 990 is therefore the first one submitted by Shiloh University to the Internal  
Revenue Service.
