The ABF follows policies and procedures designed to maximize the effectiveness of grants, as well as ensure the grant funds are used for an exempt purpose. These policies and procedures are applied consistently for grants in and outside the United States. All grants go through a pre-grant inquiry process where the grantee is required to provide extensive information on its governance practices, financial policies and program activities in general, as well as with regard to the specific program for which it is requesting funding. A formal grant agreement is then executed and countersigned by the grantee and the ABF. The grant agreement specifies the amount of the grant, grant disbursement time line, any restrictions on the grant, as well as that the grant funds must be separately accounted for by the grantee. Grantees must report back to the ABF prior to receiving release of periodic grant installment disbursements. The ABF usually makes grants in several installments to ensure compliance with program, operational and accounting requirements by the grantee organization. The grantees provide interim operational and financial reports to the ABF. The reports describe the progress in achieving the grant objectives and include detailed accounting of the uses or expenditures of all grant funds. The program directors and the evaluation team of the ABF review the interim reports and conduct site visits to ensure that the progress indicated in the reports is correct. The ABF Finance and Compliance function reviews the interim financial reports and supporting records, such as invoices and contracts. The grantees provide a copy of audited financial statements for the accounting period covering the grant, if such are available. The grantees also submit a written report summarizing the project within two months after completion of the project in which they include a complete account of the expenditures of the grant funds and detailed description of the results and accomplishments of the grant. The grantees are required to keep financial records with respect to each grant along with copies of any reports submitted to the ABF for at least two years following the year in which all grant funds are fully expended. The ABF Audit Committee and Board of Directors exercise oversight over the grants disbursed through the review of reports and presentations by management.

Grants are reported consistent with the ABF's financial statements using the accrual method of accounting. The America for Bulgaria Foundation seeks to enhance the longstanding legacy of goodwill and friendship between the American and Bulgarian people to promote US-Bulgaria people-to-people contacts. Through its grants and programs, the Foundation represents the generous spirit of the American people and embodies the highest standards of US ethical conduct, transparency, and core values.

The ABF has a total number of 33 employees. Only 3 were included in Part V, line 2a, as the remainder are employees for whom the ABF is not required to file Form W-2.

Part III, Line 3 and Part VI, Line 4

America for Bulgaria Foundation's Certificate of Incorporation was amended in 2019 to allow for transfers to Section 501 organizations as the Board of Directors of the Corporation shall determine to be used for one or more of the exclusively charitable purposes related to the development of the private sector through education, entrepreneurship, leadership development, and private sector philanthropy and volunteerism in the Republic in Bulgaria.

Subsequently, America for Bulgaria Foundation has transferred all of its assets to a 501(c)(4) organization under the U.S. Internal Revenue Code. In order to effectuate this transfer, America for Bulgaria Foundation merged into a newly formed entity called America for Bulgaria 2.0 ("ABF 2.0"), effective at 11:59 PM on December 31, 2019, with ABF 2.0 surviving the merger. Immediately following the merger, ABF 2.0 changed its name to America for Bulgaria Foundation. The company is currently awaiting review and approval of its 501(c)(4) application. This change in status resulted in change of the governing documents of the organization, including the articles of incorporation and bylaws. There were no significant changes in the content of the new governing documents compared to the ones of the legacy organization.

Part VI, Line 6

The America for Bulgaria Foundation was organized not for profit as a non-stock corporation under the General Corporation Law of the State of Delaware on December 18, 2006. The persons who serve on the Board of Directors (the governing body) of the ABF are the only members of the corporation.

The members of the corporation, who also constitute its board of directors, are entitled by the ABF's amended and restated certificate of incorporation to elect persons to the Board of Directors.

Part VI, Line 7b

Article Eight of the ABF's amended and restated certificate of incorporation provides that "The Board of Directors of the Corporation shall be divided into three classes as nearly equal in size as is practicable, hereby designated Class I, Class II, Class III. The term of office of the initial Class I Directors shall expire at the next succeeding annual meeting of the Members, the term of office of the initial Class II Directors shall expire at the second succeeding annual meeting of the Members and the term of office of the initial Class III Directors shall expire at the third succeeding annual meeting of the Members. The initial Class I, Class II and Class III Directors shall be those Directors designated as such in Article Ninth hereof. At each annual meeting of the Members, Directors to replace those of a class whose terms expire at such annual meeting shall be elected to hold office until the third succeeding annual meeting thereafter and until their respective successors shall have been duly elected and qualified. If the number of Directors is hereafter changed, any newly created directorships or decrease in directorships shall be so apportioned among the classes as to make all classes as nearly equal in number as practicable. The election of Directors need not be by written ballot. Any Director may be removed at any time, with or without cause, by a vote of the majority of the Members. Any vacancy occurring on the Board of Directors of the Corporation may be filled by a majority of the remaining members of the Board of Directors of the corporation, although less than a quorum, at any meeting of the Board of Directors of the Corporation. Any Director elected to fill any vacancy on the Board of Directors of the Corporation shall be elected to serve the unexpired term of the directorship."

The Chief Financial Officer (CFO) is responsible for the preparation and the filing of the IRS Form 990 and all necessary extensions. The Form is completed by the Finance function of the ABF. As part of the preparation process, issues are discussed with outside legal and tax counsel and an external tax service consultant for nonprofit organizations. After a review by the CFO, copies of the Form are provided to the president and the executive director of the Foundation for their review and feedback. A copy of the Form is distributed to the members of the Audit Committee of the board of directors. During a scheduled meeting of the Audit Committee, the CFO reviews the Form with the Audit Committee and any necessary changes are made. Before the Form is filed, a copy of the approved Form is provided to all officers.
