Reformation Hope, Inc. continues to provide financial assistance to the Souls Winning Ministries New Joy House Orphanage in Marin, Haiti. This facility was expanded in fy2016 and in fy2018 5 more children were added to the total being cared for, bringing the number to 83. The expanded orphanage in fy 2019 included 91 children, an increase of another 8 children. In compliance with Haitian law, the facility must keep 10% of its beds available for potential rescue children relocated from deficient orphanages elsewhere in the nation. Therefore, Souls Winning Ministries, the administrator of the New Joy House Orphanage, plans to leave the remaining beds/spaces open to accommodate potential relocated children from other Haitian facilities.

4b (Code:) (Expenses \$ 89,811 including grants of \$ 89,811) (Revenue \$)
The second largest expense/grant center for Reformation Hope, Inc. in fy2019 was financial assistance to Souls Winning Ministries in Haiti for the salaries of its director, asst. director, and New Joy House orphanage director. This assistance was also provided to assist Souls Winning Ministries in supporting an indigenous church leader for their new church and school in Jacmel, Haiti, located on the southern coast. A portion of the total (\$ 4,192) was allocated for purchasing airline tickets for the Souls Winning Director to travel between the United States and Haiti for consultations, planning for projects in Haiti, and for preparation of a 40 foot cargo container to send food, medical supplies, and donated items to Souls Winning Ministries.

Marin Medical Clinic: Reformation Hope provided grants totaling \$ 45,600 in supporting Souls Winning Ministries' Reformed Medical in the Marin/La Plaine area of Haiti, a suburb of Port-au-Prince, adjacent to Croix-des-Bouquets. The clinic serves the local community and specializes in assisting expectant mothers and their at-risk children, providing needed diagnosis and treatment. Further demand upon the clinic's services in fy2018 and fy2019 occurred due to the continuing violence and civil protests taking place in Haiti, including within the medical clinic's service area. We expect an increased patient load to continue in fy2020.

New Program Services not previously listed (Part III, no. 2):

Reformation Hope provided a total of \$8,085 in support to Souls Winning Ministries in Haiti for the purchase of a 40 foot high cube cargo container and some of the construction supplies needed, as well as construction costs for a foundation upon which to set the cargo container at the ministry's compound in La Plaine, Haiti. This container is one half of the two needed in order to create a larger, virtual classroom for the use of the high school, college, and medical clinic (tele-medicine) in Haiti.

Other Program Services (not detailed on Form 990, Part III, no. 4):

Grant funding of \$26,750 to support the continued operation of the Souls Winning High School in Marin/La Plaine, Haiti, established in the previous fall of fy2018. This school provides much needed classical style education to the children of the New Joy House orphanage and also is available at a reasonable cost to families with children of high school age within the local community.

Financial assistance of \$14,854 for supplies, payroll support, and maintenance of several under-resourced churches in rural and in inner city settings in Haiti, administered through the staff of Souls Winning Ministries.

Expenses related to mission and management team travel to and operations within Haiti of \$9,147. This is a substantial decrease from prior years' program services in this category, due to the significant travel dangers and U.S. travel advisories related to Haiti.

Souls Winning Ministries Staff Support. Reformation Hope provided grants totaling \$7,600 to Souls Winning Ministries for support of their staffing needs at the New Joy House Orphanage and other satellite locations.

Reformation Hope provided \$7,376 in assistance to Souls Winning Ministries in Haiti to further the operation of their Reformed Academy Biblio College, which provides no-cost courses leading to a bachelors degree for Haiti students.

Reformation Hope provided \$1,100 in assistance to two Haitian families, in which one or both parents were killed in armed robberies to assist either the mother or the children's extended families, in providing for the surviving children.

Emergency assistance of \$1,000 was provided by Reformation Hope to Souls Winning Ministries for aiding in the cost of medical care in hospital for one of the Haitians involved in the Souls Winning network.
