Lexington Community Radio; Arbor Youth Services; Athens West Theater Company; and Pikeville Pride.
The projects that were funded ranged widely, from public art performances, materials and resources for education, advocacy, child and youth services, and African-American minority groups.

This year our main public event was a gala celebration of Jim Gray, the first openly gay mayor of Lexington, Ky, the second largest city in the state. On Sunday, March 24th from 2-4pm at the Livery, this event featured food, music, educational materials, and several speakers. The theme was "A salute to Jim Gray and his vision of Lexington - a welcoming city that gives everyone a chance to be authentic and grow in life." Lexington was one of the earliest adopters of a "Fairness ordinance." As a Lexington Fayette Urban Co Council member & vice mayor (2006-10), and later in 2010 elected as Mayor, Jim Gray proclaimed June 29th, 2013, as "Pride Day." Mr. Gray was mayor of Lexington from 20011-2019, and ran for the US Senate against Rand Paul, then ran for the US House. Gray has publicly stated that his administration was focused on three areas: creating jobs, making govt more efficient, & to build Lexington into a great American city. Lexington earned several awards by various national organizations under his leadership, and in 2019 newly elected Governor Andy Beshear appointed Jim Gray as Ky Secretary of Transportation. In addition to his political career, Gray has a construction & development company called "Gray Construction," which as enjoyed success and profitability. As a role model for LGBTQ youth, Mr. Gray's success in both university undergrad and grad school, his success as an entrepreneur, and his success as a politician can hardly be equalled in the US South.

in 2019 Just Fund Ky continued our effort to reach out to LGBTQ persons in Kentucky to establish legacy giving programs. This was the final expenditures of the "Out in the South" grant received in 2017. The focus this year was on social media campaigning.
