THE LEAGUE IS INCORPORATED AS A TITLE X NON PROFIT CONSOLIDATED GRANTEE AGENCY CONSISTING OF A CENTRAL OFFICE AND ELEVEN SUB RECIPIENT AGENCIES PROVIDING FAMILY PLANNING SERVICES IN ALL NJ COUNTIES.
