THE PROGRAMS RMHC NE OFFERS INCLUDE TWO HOUSES: RMH PROVIDENCE AND RMH BOSTON HARBOR, OUR TWO RM FAMILY ROOMS (ONE AT HASBRO CHILDREN'S HOSPITAL IN PROVIDENCE, RI, AND ONE AT MASS GENERAL HOSPITAL FOR CHILDREN IN BOSTON, MA), AND OUR TWO RM CARE MOBILES (ONE IN RHODE ISLAND AND ONE IN WORCESTER, MA).

THE RONALD MCDONALD HOUSES PROVIDE A "HOME" ALLOWING FAMILIES TO EAT, SLEEP AND FIND THE EMOTIONAL SUPPORT THEY NEED TO CENTER THEIR ENERGY ON THEIR SICK CHILD. FAMILIES ARE PROVIDED WITH CLEAN, PRIVATE, SAFE AND PROXIMATE ACCOMODATIONS ALLOWING THEM TO FOCUS ON THEIR CHILD'S CARE. WE SUGGEST A \$10 PER NIGHT CONTRIBUTION FROM FAMILIES; HOWEVER, NO FAMILY IS EVER TURNED AWAY IF THEY ARE UNABLE TO PROVIDE THAT CONTRIBUTION.
