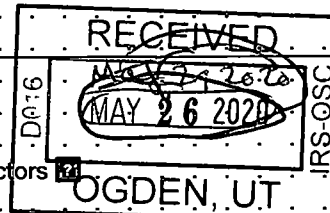



The following explanations apply:

There was a typographical error in line 27 of the 2018 form 990ez. The total assets were shown as \$129,126,

when the correct amount, as shown on line 21, should have been \$229,126

The Project held an investment in Sostanica, a micro lender, valued in 2018 at \$7,800. During 2019

Sostinica went bankrupt. The investment has been written off, but amounts received from the entity have been
shown as income when received.

The project has historically expensed amounts sent to Nicaragua to support the programs there

as transferred to accounts in Nicaragua, rather than when actually spent in Nicaragua. The project has changed

this method of accounting to one in which amounts are expensed when actually spent in Nicaragua. Bank account balances
in Nicaragua are now shown as assets.

During 2019 there has been significant political turmoil in Nicaragua and the US has imposed sanctions.

The project owns a community center and an organic farm property in Nicaragua that were collectively valued at

\$149,637 at the end of 2018. Whether the project could actually realize this amount as an asset is doubtful

at the present time, so this asset has been written down to a nominal \$1,000 as of the end of 2019.

The net total of these adjustments resulted in the reduction of assets by \$49,433 as shown on line 20.
