Awards are made by the Society's Committees in accordance with the following principles: 1. Grants are intended to assist investigators by providing for costs of research work, such as the collection of scientific and literary materials; preparation of photographs, microfilms, and other records; purchases of supplies; necessary travel; and other incidental expenses of research. 2. Grants are not made toward the payment of salaries of members of the staff of an educational or scientific institution. Grants may not include institutional overhead. When a grant is made to a member of an institution to assist him or her in research of scholarly writings, it is expected that the institution will cooperate in facilitating the work. 3. Grants are not made for: (a) salaries, fellowships, scholarships, or other projects involving personal expenses over long periods; (b) subsidies for publication; (c) usual or permanent equipment for the institution involved (but may be made for special apparatus needed in the proposed research); (d) travel to meetings; (e) expense of grantee's family. 4. Support of a long-continuing project is not undertaken, except in its initial stage. 5. No recipient of a grant shall thereby become an employee of the Society. The written agreement with each grantee sets forth the specific objectives of the grant and requires each recipient to file a written report with the Society. In the formal notification sent to all recipients of grants there is a request that credit be given to the Society in the publication of work supported by such grants and that a copy of each publication be sent to the Society. To this has been added another statement that the Committee on Publications would appreciate an opportunity to consider publication of a manuscript, but there is no obligation that such a paper be published by the Society.
